## **New Trails & Blueways Council**

The Prince William Board of County Supervisors (BOCS), in partnership with the Prince William County Park Authority, has approved the creation of a Trails and Blueways Council (Res. 09-502) to advise the Park Authority and the BOCS on the development of a County-wide trails and blueways system. The BOCS approved changes to the Parks, Open Space and Trails components of the Comprehensive Plan in 2008. Jay Ellington, Executive Director of the Park Authority, is looking forward to working with the Council. Mr. Ellington says he is "confident that with the establishment of our Trails and Blueways Council, Prince William will soon have a first class trails system for our citizens to enjoy and be proud of." Mr. Ellington and his staff will serve as the County staff representative for the Council.

## Changes to SWM Regulations

The Virginia Department of Conservation and Recreation's Soil and Water Conservation Board is proposing changes to storm water management (SWM) program regulations to include increasing the limits on phosphorus discharges and expanded detention capability for SWM facilities.

Industry experts and civil engineers have expressed concern that compliance with the new requirements will pose a significant financial burden to landowners and

The BOCS is expected to vote on the Land Use and Transportation Chapters this fall, following the Business Community Meeting.

The Environment Chapter is under review by the Planning Commission (PC); a first draft of proposed changes is expected on September 2, 2009.
